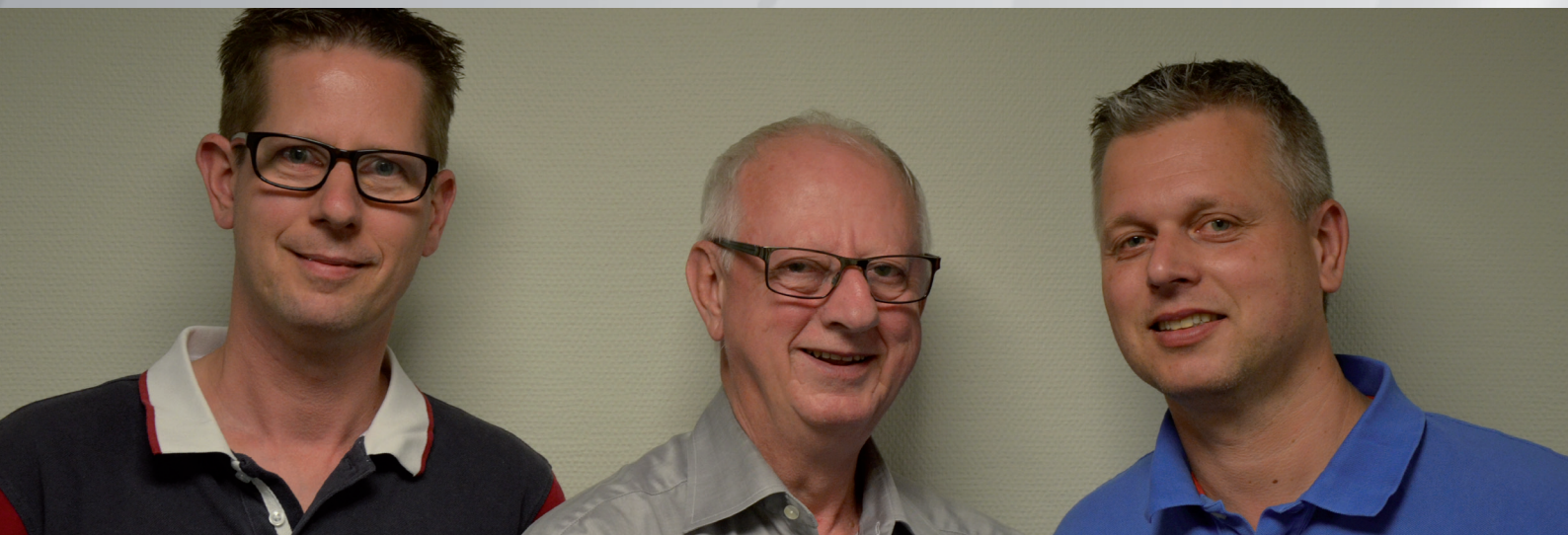

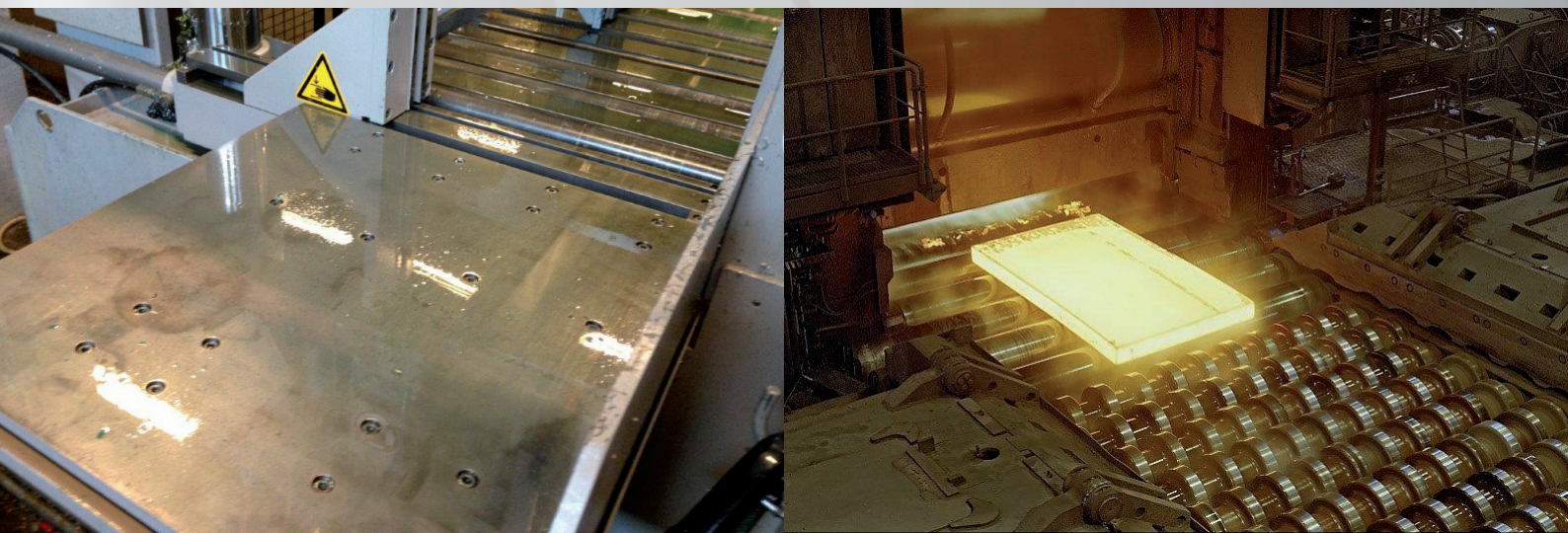

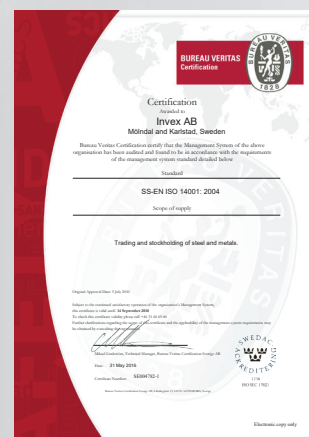
Invex invests in the environment and quality

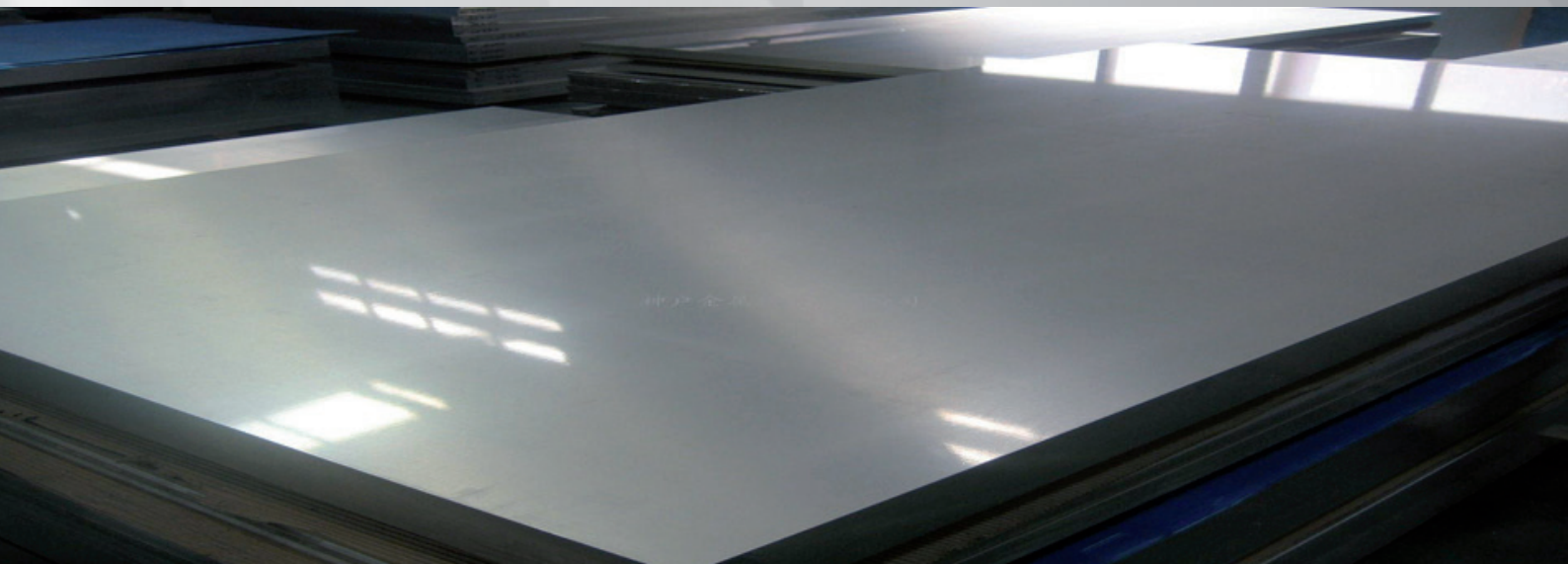

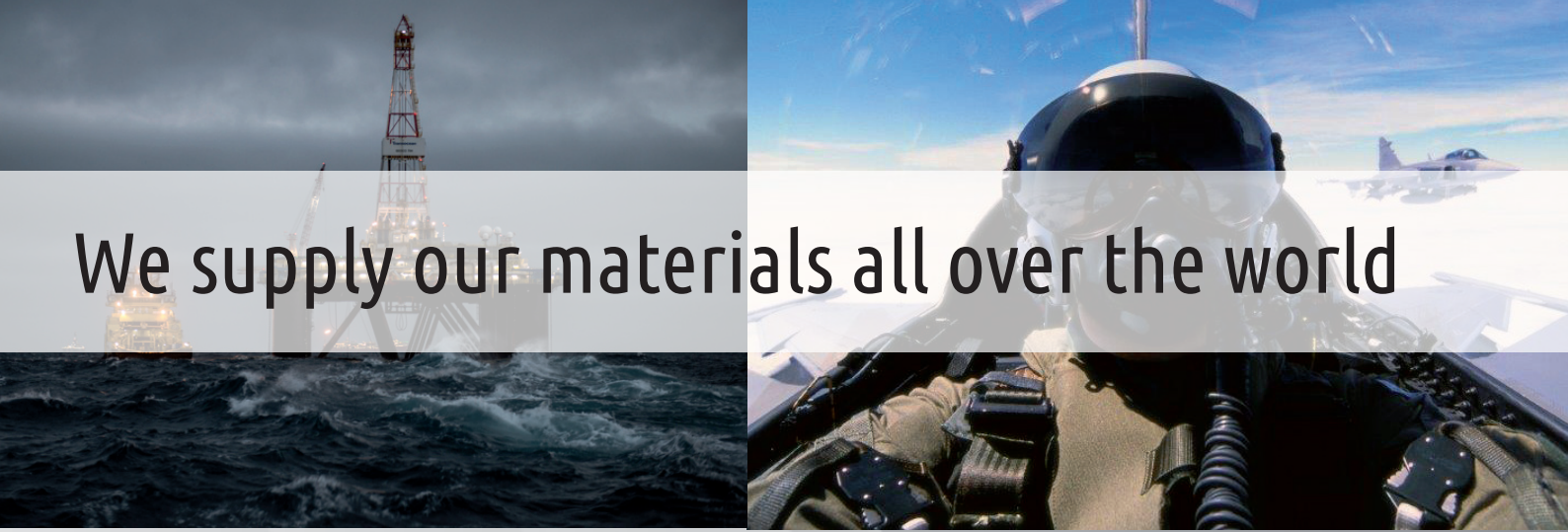
